

ST. REGIS CATHOLIC SCHOOL FINANCIAL POLICY 2011-2012

FEES

REGISTRATION FEE:

Registration for *returning* families is \$250.00 per family due by 2-18-11. Registrations will not be processed for any family with an outstanding financial obligation (tuition and offertory contributions) for the 2010/2011 school year.

The Registration Fee for *new* families at St. Regis Elementary School is \$350.00 per family. This fee is due at time of acceptance to the school and registration materials are completed. It is considered an additional part of the tuition and is *non-refundable*.

EIGHTH GRADE FEE:

There is a \$100.00, *non-refundable*, fee for students entering the eighth grade.

SCREENING FEE:

All *new* students must be screened prior to acceptance at St. Regis. Children progressing from Junior Kinder to Kindergarten are not charged a screening fee. The fee for children entering Kindergarten and 1st grade is \$150.00 per student; children entering Grades 2-8 is \$50.00 per student. The fee is due at the time of screening and is *non-refundable*.

MATERIALS FEE:

The Materials Fee is \$350.00 for each student and is *non-refundable*. This fee is due by May 15 for returning St. Regis families. Separate bills will not be sent. For families new to St. Regis Elementary School, the fee is due at the time of registration. This fee covers supplies, including paper products (tissue, wipes, etc.) in the classroom, books and instructional materials.

Parish Contribution is for the 2011 calendar year, January through December 31, 2011 and based on 2011-2012 enrollments.

Parish Contribution must be paid in full by December 31, 2011 for the 2011/2012 school year.

OUT OF PARISH TUITION Grades K-8

Per Student \$8,975.00 each child + Fees

JUNIOR KINDER TUITION

Per Student \$3,450.00 each child + Registration Fee and Materials Fee

Junior Kinder does not affect the number of children enrolled for tuition purposes.

DEFINITION OF "IN PARISH"

Family must be registered, active parishioners at St. Regis or another Roman Catholic Parish and participate in the ministry of the Catholic Church in accord with norms of the Code of Canon Law C.204 in the following manner: Parents and students will cooperate to assist the staff in creating a healthy learning environment in which all students are encouraged to develop their Catholic values, talents and to grow in their spiritual life. Family support for the ministry of the Catholic Church will be manifested in the willingness to share time, talent and treasure.

TIME: Each family will worship at St. Regis on Sunday, honor the Holy Days of Obligation and support the ministry of the church through a spirit of volunteerism/service.

TALENT: Individuals will use their talents to further the mission of the Catholic Church and support the school by placing these talents at the use of the church and school.

TREASURE: School families will contribute a minimum, as stated above, in the offertory collection. This minimum assists in defraying the cost of the parish subsidy for the school. In addition, each new family is expected to contribute a minimum to the *Regis Fund* yearly, as well as the *Catholic Services Appeal (CSA)*.
